Soumil was rusticated from the College, only excused to sit for the final semester examination.

 college website as well as in the college premises.
- Students were also made aware of the activities of this Anti-Ragging committee through filling up the forms during admission process.

Annual Report of Internal Complaints Committee 2018-23

- One Internal Complaints Committee, a statutory body was formed vide Notification No. 1307 dated 28.09.2018. It deals with the complaints made by the students in the college related to sexual harassment. This committee works in association with Local Complaints Committee (LCC) and Grievance Cell.
- A program was organised on 19.08.2019 to generate awareness amongst the newcomers mainly UG 1st Semester students of Bidhannagar College regarding activities of ICC. The convenor of ICC personally met the students on 19thAugust, 2019. The convenors of the other two committees accompanied the convenor of LCC. Students were informed about the activity of both ICC and LCC. For any kind of personal harassment in College premises they may personally contact the committee of ICC or they may put up their complaints in the Grievances boxes placed in different places of old and New Buildings.
- There was no case reported in the year 2019-20, 2020-21, 2021-22 and 2022-23.
- There is only one case reported under ICC in the assessment period (2018-19), i.e, Kaushik Mahatao, 2nd year student of Microbiology assaulted Swagata Sharma, 1st Year student of English Department. The case was resolved under ICC by an undertaking from the former. The detailed minutes of meetings regarding the event were recorded in ICC meeting register.
